#### A. Call to Order:

Bryan Brockson called the meeting to order at 7:40. Jim Scanlon introduced Shelby Speaker, a student at Rustin HS, recommended student representative for 2015-2016 and Ken Witmer, Dean of the College of Education at West Chester University, who is also joining the board.

# B. Approval of Minutes:

#### C. Treasurer's Report:

She also reported that the Chester County Chamber of Business and Industry supports about twenty students for their Youth Leadership program. Deb is also looking to increase student participation in the Junior Achievement program, an after-school mentoring program. She asked the board for suggestions of large companies that may want to get involved.
