- ❖ The West Chester Area School District and its board members, administration, contractors and employees (collectively “WCASD”) have no responsibility for or control of the Drivers, Student or other passengers once the Drivers depart the Fugett Middle School campus or the sporting competition venues.
- ❖ The Drivers are not employees, agents, independent contractors, volunteers or representatives of WCASD when driving their vehicles to and from sporting competition venues or transporting

student-athletes. The Drivers have been selected solely by the Parent/Legal Guardian and have not been subject to any background review by WCASD.

- ❖ WCASD does not provide insurance coverage of any kind for Drivers, the Student or the passengers while driving to and from competitions in their vehicle.
- ❖ I agree to release, indemnify, defend and hold harmless the WCASD from and against any and all losses, demands, claims, causes of action, liabilities, damages, costs, expenses including reasonable expert and attorneys' fees and/or judgments relating to or arising out of the release of the Student to the Drivers or the Student's transportation by the Drivers to or from sporting competition venues, including, without limitation, injuries, up to and including death to the Student, injury to the Student's property, and injury to property or third parties.
