# Resolution to Adopt Proposed Budget for the 2013-2014 Fiscal Year

**Whereas,** School Code section 687, 24 P.S. § 6-687, requires the School Board to adopt a Proposed Budget for the 2013-2014 fiscal year no later than May 31, 2013; and

**Whereas,** School Code section 687 requires the School Board to adopt a Final Budget for the 2013-2014 fiscal year no later than June 30, 2013; and

**Whereas,** the 2013-2014 Proposed Budget is required to be prepared on Pennsylvania Department of Education (PDE) form 2028; and

**Whereas,** School Code section 687 requires that the Proposed Budget be made available for public inspection at least twenty (20) days prior to adoption of the Final Budget; and

**Whereas,** School Code section 687 requires ten (10) days public notice prior to the adoption of the Final Budget; and

**Now Therefore be it RESOLVED,** this 22nd day of April, 2013 by the West Chester Area School District School Board, that:

- 1. The Proposed Budget of the School District for the 2013-2014 fiscal year on form PDE 2028 is attached to this Resolution and shall be adopted as the Proposed Budget of the School District for the 2013-2014 fiscal year.
- 2. The Proposed Budget for the 2013-2014 fiscal year shall be made available for public inspection on April 23, 2013 at the School District offices, 829 Paoli Pike, West Chester, PA 19380.
- 3. At least ten (10) days before the date scheduled for adoption of the Final Budget, the Secretary shall advertise public Notice of the proposed date, time and place for the meeting for the adoption of the Final Budget.

- 4. The public Notice shall be advertised once in a newspaper of general circulation and shall be posted conspicuously at the School District offices.
- 5. The Administration and School Board will continue to review budget components, and the Proposed Budget may be revised prior to adoption as the Final Budget for the 2013-2014 fiscal year.
- 6. School District officials are directed to take all action necessary or appropriate to carry out the intent of this Resolution; including but not limited to making the required certification to PDE.
